

## DECLARATION OF RESIDENCY – ATTN: CORPORATE ACTIONS

The common shares (“**Common Shares**”) issuable pursuant to a prospectus dated April 3, 2019 to qualify a special dividend of Century Metal Inc.’s (the “**Issuer**”) common shares by Century Global Commodities Corporation (“**Century Global**”) will not be delivered to any registered or beneficial holder of Century Global common shares who is, or who appears to Century Global, the Issuer or TSX Trust Company (the “**Trustee**”) to be, a resident in the Province of Quebec or a resident in the United States of America (collectively, the “**Ineligible Jurisdictions**”).

Century Global and the Issuer reserve the right to make a determination of residency in their sole discretion. **If a holder fails to declare that they do not reside in the Ineligible Jurisdictions by completing the appropriate box below and returning this declaration to the Trustee on or before June 10, 2019, they may be deemed to be ineligible on that date.** With respect to registered holders of Century Global common shares whose address on the Century Global shareholder register on May 31, 2019 (the “**Record Date**”) is in jurisdictions, other than the Ineligible Jurisdictions, Century Global and the Issuer may consider such holders to be eligible holders. **If a broker or other Depository participant fails to provide the necessary declaration on behalf of their clients on or before June 10, 2019, the applicable beneficial holders of Century Global common shares may be deemed to be ineligible on that date.**

The following form is for use by registered holders of Century Global common shares. If you hold your common shares in Century Global through a brokerage or other account through CDS Clearing and Depository Services Inc., the broker or other Depository will need to respond to the residency declaration on your behalf.

**Registered holders of Century Global common shares who resides in the Ineligible Jurisdictions must complete and return this form.**

The undersigned hereby represents and warrants to Century Global, the Issuer and the Trustee, and acknowledges that each is relying thereon, that the undersigned (and, if the undersigned holds Century Global common shares on behalf of a beneficial owner, such beneficial owner) IS NOT a resident of residing in the Province of Quebec or in the United States.
